IN 2024, GLOBAL CITIZEN HOSTED MULTIPLE GLOBAL CAMPAIGNS THAT AIMED TO FURTHER ITS MISSION TO END EXTREME POVERTY. THE POLICY AGENDA FOR 2024 CENTERED ON DEFEATING POVERTY BY FOCUSING ON HEALTH, FOOD SECURITY, FINANCING FOR DEVELOPMENT, PROTECTING THE PLANET, AND ENSURING ADVOCATES EVERYWHERE HAVE THE OPPORTUNITY TO CALL FOR REMOVING SYSTEMIC BARRIERS THAT KEEP PEOPLE IN POVERTY.

GLOBAL CITIZEN'S MISSION IS TO BUILD THE WORLD'S LARGEST MOVEMENT OF ACTION-TAKING GLOBAL CITIZENS TO END EXTREME POVERTY NOW.
